

RULES/TERMS AND CONDITIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

A purchase will not improve chances of winning.

OPEN ONLY TO HIGH SCHOOL students AGED 16 or 17 AT THE TIME OF THE TOUR (Tour dates June 5-9, 2021) LIVING WITHIN THE VALLEY TELEPHONE COOPERATIVE OR COPPER VALLEY SERVICE AREAS.

This Promotion is sponsored by Valley Telephone Cooperative, Inc., located at 752 E. Maley St., Willcox, AZ (the "Sponsor.").

By entering this Contest, entrants accept and agree to be bound by these Official Rules. Any violation of these rules may, at Sponsor's discretion, result in disqualification. All decisions of the judges regarding this Contest are final and binding in all respects.

- **1.** PROMOTION PERIOD. Promotion begins December 1, 2020 and ends February 26, 2021, or when prize has been claimed ("Promotion Period").
- 2. ELIGIBILITY. This contest (the "Promotion") is only open to school aged children living within the Valley Telephone Cooperative or Cooper Valley service territories. To add some guidance to the areas we serve these are the schools that are within our Cooperative service territory: Animas Schools, Apache Elementary, Columbus Elementary, San Simon, Bowie, Bonita Elementary, Pearce Elementary, Ash Creek Elementary, Valley Union, Duncan and Morneci. Homeschool students residing in the Valley Telephone Cooperative Copper Valley service area are also eligible to enter the contest. (Valley Customers living in Safford, Willcox or Tombstone are not eligible.)

Parent(s)/Guardian(s) must be a current active customer of Valley TeleCom Group for a period of at least a year.

Student must have a valid Driver's license or State issued ID suitable for identification purposes for plane travel.

Legal residents of the state of ARIZONA and NEW MEXICO, **except** officers, directors, and employees of the Sponsor, and their immediate family (i.e., parents, children, siblings, spouses). This Promotion is void outside the states of ARIZONA or NEW MEXICO and where prohibited.

3. HOW TO ENTER.

- 1. Submit an essay on the topic: What moment in American History do you wish you had been a part of and what would you have contributed.

4. Students who submit essays will be interviewed at Valley TeleCom's Willcox and/or Animas office between March 8 & March 19, 2021.

4. HOW TO CLAIM A PRIZE. The winners will be notified by a Valley representative and additional arrangements will then be made to include the winner on the Washington Youth Tour hosted by Foundation for Rural Service. Winner and parent/guardian may be required to complete an affidavit of eligibility, a media release form and provide personal information to facilitate prize delivery.

6. PRIZE DESCRIPTION.

Two (2) winners will be chosen as delegates to represent Valley TeleCom Group at the Foundation for Rural Service's Washington Youth Tour. The delegates will receive an all expensed paid 5-day trip to the Nation's Capital with visits to historic sites, national landmarks, and the opportunity to meet their peers in planned student activities. The tour will be from Saturday, June 5- Wednesday, June 9, 2021.

- 7. WINNER SELECTION. At the end of the Promotion Period, Entries will be judged by the staff of Valley TeleCom group. Entries will be judged on the basis of originality, theme, communicative ability and format. Scores from the submitted essay and the interview will be combined to determine the final winners. All entries become the property of Valley TeleCom Group and may be used or reproduced in any manner without additional consent or compensation.
- 8. TAXES. All federal, state and/or local income and other taxes, if any, are the winner's sole responsibility.
- **9.** NO PRIZE TRANSFER OR SUBSTITUTION. No prize or any portion thereof is transferable or redeemable for cash. Any portion of the prize that is not used is forfeited. No substitutions for prize except by Sponsor, in which case a prize of equal or greater value will be substituted.
