## Washington Youth Tour Competition



Valley TeleCom Group is inviting all high school juniors to enter the Washington Youth Tour Competition for an opportunity to visit Washington DC in June 2021. The competition will consist of an essay and interview.

**Essay Topic: What moment in American History do you wish you had been a part of and what would you have contributed.**

**Essay Format:** Write a 500-word essay. This must be typed and double spaced. Please do not include your name on your essay as copies will be sent to our judges. Submit your essay with the attached application for identification purposes.

### Eligibility

1. The contest is open to all high school students, age 16 or 17 at the time of the tour. (Tour dates June 5-9, 2021)
2. Student must be living with in the Valley Telephone Cooperative Service or Copper Valley serving territories. To add some guidance to the areas we serve these are the schools that are within our Cooperative service territory are: Animas Schools, Apache Elementary, Columbus Elementary, San Simon, Bowie, Bonita Elementary, Pearce Elementary, Ash Creek Elementary, Valley Union, Duncan, and Morenci. Homeschool students residing in the Valley Telephone Cooperative or Cooper Valley service area are also eligible to enter the competition. (Valley customers living in Safford, Wilcox or Tombstone are not eligible.)
3. Parent(s)/Guardian(s) must be a current active customer of Valley TeleCom Group for a period of at least a year.

4. Student must have a valid Driver's license or State issued ID suitable for identification purposes for plane travel.

## **Rules & Regulations**

1. Entries must be received by February 26, 2021. 2. Entries will be judged by the staff of Valley TeleCom group. Entries will be judged on the basis of originality, theme, communicative ability and format.

3. Students who submit essays will be interviewed at Valley TeleCom's Willcox and/or Animas office between March 8 & March 19, 2021.

4. Scores from the submitted essay and the interview will be combined to determine the final winners.

5. The winners must agree to allow Valley TeleCom Group to publish his/her name (on the Valley TeleCom website, social media platforms and in the Annual Meeting Notice booklet. Winner addresses and email addresses will be kept confidential and will NOT be published.

## **Winners**

Two winners will be chosen as delegates to represent Valley TeleCom Group at the Foundation for Rural Service's Washington Youth Tour. The delegates will enjoy an all expensed paid 5-day trip to the Nation's Capital with visits to historic sites, national landmarks, and the opportunity to meet their peers in planned student activities. The tour will be from Saturday, June 5- Wednesday, June 9, 2021.
