



RULES/TERMS AND CONDITIONS

OPEN ONLY TO LEGAL BUSINESSES OF THE STATES OF ARIZONA AND NEW MEXICO WHOSE AUTHORIZED REPRESENTATIVES ARE AT LEAST 18 YEARS OLD.
