**Acceptable Documentation Proof of Qualification Through Your Income\***

1. The prior year's state or federal tax return;
2. Current income statement from an employer or paycheck stub;
3. Social Security statement of benefits;
4. Veterans Administration statement of benefits;
5. Retirement or pension statement of benefits;
6. Unemployment or Workers' Compensation statement of benefits.

*\*If the documentation does not cover a full year, such as current pay stub, the subscriber must present the same type of documentation covering three consecutive months within the previous 12 months.*
